The **IX Postgraduate Conference: Management, Hospitality & Tourism** is organised by the School of Management, Hospitality & Tourism, University of the Algarve, and by the Lisbon Accounting and Business School, Polytechnic Institute of Lisbon, and this ninth edition will take place **on 6 July 2018**. - The completed form should then be emailed to: [pgconference2018@ualg.pt](mailto:pgconference2018@ualg.pt), with the subject heading 'Abstract: presentation' or 'Abstract: poster';

**Conference languages:** Portuguese, English and Spanish.

**Presentations** will be limited to 20 minutes, plus 10 minutes for discussion. Papers will be organised in thematic panels.

**Posters** (A1 size, 594mm x 841mm) will be exhibited in a specially designated area. Authors of posters will be allotted a time during which they can present and discuss their poster in the session **WTT: We Talk Together**.
