



2nd Call for Papers

The **X Postgraduate Conference: Management, Hospitality & Tourism** is co-organised by the School of Management, Hospitality & Tourism, University of the Algarve, and by the Lisbon Accounting and Business School, Polytechnic Institute of Lisbon, and this tenth edition will take place on **5 July 2019**, in Lisbon. Presentations: 20 minutes (+ 10 minutes for discussion) organised in thematic sessions.

Posters: (dimension A1, 594mm x 841mm) exhibited and presented at a time to be set in the programme. There will be a WTT session: We Talk Together - showcase of research papers with the possibility of debate between authors and participants.

Conference Languages: Portuguese, English and Spanish.

Important information:

- All papers are anonymously evaluated by a minimum of two scientific reviewers;
- Each registered author cannot make more than two presentations;
- The preparation, printing, transport and placement of the poster (on the day of the conference) are the responsibility of the participants.

Publication Opportunities

All abstracts of papers presented at the conference will be published in the X Postgraduate Conference booklet with ISBN.

After the conference, participants will be able to submit their work to the academic publications associated with the event.
